SECTION 3 - HAZARDS IDENTIFICATION ACUTE OVEREXPOSURE EFFECTS

EYE CONTACT:

In a lifetime inhalation study female rats exposed to an elevated respirable concentration (9 times the Permissible Exposure Limit) of cosmetic grade talc developed lung cancer. High exposures to xylenes in some animal studies have been reported to cause health effects on the developing embryo and fetus. These effects were often at levels toxic to the mother.
